<p>meeting of their respective roles and what if any assistance they can offer. Sharon is new to her role and has been appointed as a liaison with parish meetings / councils and the highways department.</p> <p>Many at the meeting felt that the repeater signs had not helped. Paul Shepherd described the speed matrix which would calculate the average speed of vehicles and then demonstrate if there is a problem this can also look at particular times of the day which are worse / better. If a problem is identified then speed traps may follow timed to correspond with the data collected. The major problem facing the village is funding which works on a points system with villages needing to score a minimum of 15 points to gain funding. These points are awarded for personal injury. The options discussed include warning signs costing approx. £400, and vehicle activated signs costing approx. £4000. Police also operate a simple sid which is a village held speed camera which is not enforceable but can be used as a further discussion point.</p> <p>Speeding concerns forms need to be completed which are available from WHPM website or from any member of the committee. These forms will provide the evidence for a speed matrix the first step needed to assess the issue.</p>
